The decisions shall come into force on 01st of August, 2004.

SCHEDULE

The decisions made by the Wages Board for the Ceramic Products Manufacturing Trade and set out in the Schedule to the Notification published in *Gazette Extraordinary* No. 1099/07, of 28th September, 1999, as varied from time to time and last varied by the Notification published in *Gazette Extraordinary*, No. 1258/25 of 28th October, should be further varied by substitution of the following paragraph.

CLASS OF WORKERS

1. **Skilled.**— Section heads, miscellaneous machine operators, designers, charge handers, kiln operators, oven operators, senior lift operators, mould makers, research assistants, sculpture makers, artists, checkers, electricians.
2. **Semi Skilled.**— Asst. mould makers, colour blenders, sorters, junior lift operators, polishers, packers, clearners, products sticker binders, shovel loader operators, assistant machine operators, electricity generator machine operators, assistant oven operators.
3. **Unskilled.**— Cleaners, helpers, ordinary workers, gardeners and other related services.
4. **Apprentices.**— Workers engaged in miscellaneous duties for a training period of two years.
