#### FILLING OF A VACANCY IN THE OFFICE OF CHAIRMAN OF THE PADIYATALAWA PRADESHIYA SABHA UNDER SECTION 65A (1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the Office of Chairman in Padiyatalawa Pradeshiya Sabha has fallen vacant by reason of death ;
