### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Notice under Section 7

Land Ministry's Reference No.: LD/5/2002/WS/268.  
Divisional Secretary's Reference No.: 1/5/1/28.

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for Greater Kandy Water Supply Project.

Description of the land to be acquired:

1. An allotment of land called Pondawahena situated at Kurugoda presently called Hurigolla village in Udagampaha Korale Akurana Divisional Secretary's area in Kandy District, Central Province and surveyed by the Surveyor-General in his PP No. Kandy 5598 and marked as Lot No. 01, in extent of 0.0024 Hectare.

North: Pondawahena and Lots 3 and 2; East: Lot No. 2 and Pondawahena; South: Pondawahena Lot No. 2 in PP Kandy 5481 and Lot 1 in PP Kandy 5481; West: Lot No. 1 in PP Kandy 5481 and Pondawahena; Claimant: S. H. M. Saleem, 5/32, Kurugoda, Akurana.

2. An allotment of land called Pondawahena, situated at Kurugoda presently called Hurigolla village in Udagampaha Korale, Akurana Divisional Secretary's area, in Kandy District, Central Province and surveyed by the Surveyor-General in his PP No. Kandy 5598 and marked as Lot No. 2 in extent of 0.0009 Hectare.

An allotment of land called Pondawahena, situated at Kurugoda presently called Hurigolla village in Udagampaha Korale, Akurana Divisional Secretary's area, in Kandy District, Central Province and surveyed by the Surveyor-General in his PP No. Kandy 5598 and marked as Lot No. 09, in extent of 0.0214 Hectare.

North: Pondawahena; East: Pondawahena and Lot 8; South: Road, (Pradeshiya Sabha); West: Road, (Pradeshiya Sabha) and Road, (Road Development Authority); Claimant: M. I. A. Cadar, No. 347, Kurugoda, Akurana.

All persons interested in the aforesaid land are hereby required to appear personally or by agents duly authorised in writing before me at Divisional Secretariat on the 13th day of August, 2004, at 10.30 a.m. and are hereby requested to notify to me in writing (in duplicate) on or before the 30th day of July, 2004 the nature of their interests in the land, the particulars of their claims for compensation for the acquisition of the said land, the amount of compensation and the details of the computation of such amount.
