#### SCHEDULE

The decisions made by the Wages Board for the Nursing Home Trade and set out in the schedule to the notification published in *Gazette* No. 104 of 22nd March, 1974 as varied from time to time and last varied by the notification published in *Gazette Extraordinary* No. 1173/04 of 26th February, 2001, shall be further varied by the substitution for paragraph 6 of Part II of that Schedule of the following new Paragraph:-

#### CLASS OF WORKER

##### Grade I

Matrons, Apothecaries

##### Grade II

Pharmacists, Nursing Sister, Laboratory Technologists, X'ray Technicians

##### Grade III

- a) Nurses, Midwives, Storekeepers
- b) Trainee Nurses:-
  - 1st year of training
  - 2nd year of training
  - 3rd year of training

*Grade IV*

Clerks, Typists, Receptionists, Telephone operators, Cashiers.

*Grade V*

Attendants, Dispensers, Surgical Dressers, Stewards, Overseers, Ward Clerks, Diet Clerks

*Grade VI*

Orderlies, Peons, Cooks, Watchers, Conservancy Labourers

*Grade VII*

Linen Room Attendants, Labourers, Graden Labourers, Sweepers, Pantry Boys.

“Year” in relating to any trainee nurse shall be deemed to consist of twelve months employment.
