THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Disanayake Mudiyanseelage Anura Kumara Disanayake, Minister of Agriculture, Livestock, Lands and Irrigation, hereby declare under sub-section (1) of section 5 of the Land Acquisition Act, that the land described below as needed for a public purpose and will be acquired under the provisions of that Act.
