Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired :

‘A’ to ‘C’ (3) Allotments of land in total extent of about 0.2030 Hectare, depicted in advance tracing No. B/WLM/2001/594 of 2002.06.30 prepared by the Surveyor-General situated in village of Kotawera Pallegama in Dehivini Palatha Kotawera Minor Division in Uva Paranagama Divisional Secretary’s Division in Badulla District and bounded as follows:

1. **Lot ‘A’ – Pattiyamadawatta – Extent: About 0.0075 Hectare**
North: Road; East: Road and Lot B; South: Lot B and Road; West: Lot B and Road.

2. **Lot ‘B’ – Pattiyamadawatta – Extent: About 0.1931 Hectare**

North and East: Lot B; South: Pattiyamadawatta claimed by M. G. M. M. Jayasinghe and Road; West: Pattiyamadawatta claimed by M. G. M. M. Jayasinghe, Road and Lot B.
