PART I : SECTION (I) — GENERAL

THE COCONUT DEVELOPMENT ACT, No. 46 OF 1971

Order under Section 2

BY virtue of the powers vested in me by sub-section (3) of Section 2 of the Coconut Development Act, No. 46 of 1971 as last amended by Act, No. 40 of 2003, I, Anura Priyadarshana Yapa, Minister of Plantation Industries, do by this Order amend the Order made under Section 2 of the aforesaid Act and published in the Ceylon Government *Gazette* No. 15,004 of March 30, 1972, as follows :—

- (1) by the repeal of paragraphs (6), (7) and (8) of that Order and the substitution therefor of the following paragraphs :—

“(6) fix the number of members of the Board, the number so fixed being not more than eleven ;

(7) appoint the persons specified in the Second Schedule hereto as the members of the Board ; and

(8) appoint any member from among the members of the Board as the Chairman of the Board. ”.

- (2) by the repeal of the Second Schedule such Order and the substitution therefor of the following Schedule :—

“SECOND SCHEDULE

MEMBER OF THE COCONUT RESEARCH BOARD

The following persons shall be :—

(a) *ex-officio* members :—

- (i) the Director of the Coconut Research Institute established under the Coconut Research Ordinance, No. 29 of 1928 ;

- (ii) the Chairman of the Coconut Cultivation Board established under the Coconut Development Act, No. 46 of 1971 ;
 - (iii) the Chairman of the Coconut Development Authority established under the Coconut Development Act, No. 46 of 1971 ; and
 - (iv) the Director-General of the Department of Agriculture ; and
- (b) nominated members :—
- (i) a representative of the Ministry of the Minister in-Charge of the subject of Plantation Industries ;
 - (ii) a representative of the Minister in-Charge of the subject of Finance ;
 - (iii) a representative of the Coconut Growers Association ;
 - (iv) a representative of the Private Sector Coconut Processing Industry ;
 - (v) two members who have gained eminence in the field of science nominated by the Council for Agriculture Research Policy (CARP), in consultation with the Chairman, Coconut Research Board ; and
 - (vi) one member nominated by the Minister in-Charge of the subject of Plantation Industries to represent the coconut development sector. ”.
