FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE POOJAPITIYA PRADESHIYA SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)
