- (a) by the deletion in the said Notification of the Heading “Minister of Finance” and the substitution of the Heading “Minister of Finance and Planning” thereto ; and  
by the inclusion of the following words at the end of the Column II under the said Heading.

“Formulation and Development of National economic and financial Policies”

“Formulation and appraisal of plan implementation strategies”

“Perspective Planning for all sectors of the National Economy”

“Formulation and appraisal of National Economic Policies, Programmes and Strategies”

“Preparation of National Development Plans and Public Investment Programmes”

“Foreign Aid and Technical Co-operation”

“Monitoring and the Review of Progress of all Plans, Programmes and Projects of Government”

“Monitoring progress of Public and Private Sector Investment Programmes”

“The Co-ordination of the implementation programmes of Government and Non-Government agencies for the achievement of national objectives”

“The evaluation of the performance of Institutions and enterprises engaged in economic activities”

(b) by the deletion in the said Notification of the Heading “Minister of Constitutional Reform” and the substitution of the Heading “Minister of Constitutional Affairs and National Integration” thereto.

(c) by the inclusion of the words “NCP Rural Development Project” at the end of Column I under the Heading “Minister of Mahaweli and River Basin Development and Rajarata Development”.

(d) by the deletion of the words “Information Technology Parks” appearing in Column I under the Heading “Minister of Agricultural Marketing Development, Co-operative Development and Hindu Affairs and Minister Assisting Education and Vocational Training” ; and

by the inclusion of thereto of the following words,

“Information Technology Parks (except Malabe Information Technology Park)”

(e) by the inclusion of the words “Malabe Information Technology Park” at the end of Column I under the Heading “Minister of Urban Development and Water Supply”

(f) by the inclusion of the words “Homoeopathic Council” at the end of Column II under the Heading “Minister of Indigenous Medicine”.
