THE REVENUE PROTECTION ACT, No. 19 OF 1962

ORDER

IN pursuance of the powers vested in me by Section 2 of the Revenue Protection Act, No. 19 of 1962, I, Sarath Amunugama, Minister of Finance, do by this Order from 20th September, 2004 require the Director General of Customs to demand the levy on each article specified in Column 3 of the Schedule hereto, import duty at the general rate set out in the corresponding entry in column 5 of that Schedule or where a preferential rate is leviable and payable under Provisions of Schedule 'A' of the Customs Ordinance (Chapter 235) at the preferential rate set out in the corresponding entry in Column 4 of that Schedule.
