##### Notice under Section 7

I hereby give notice, under Sub-section (1) of section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Anura Kumara Dissanayake, Minister of Agriculture, Livestock, Lands and Irrigation do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Three (03) allotments of land known by the names and in extents hereunder containing in extent 0.0651 Hectare out of the entirety of land depicted in the advance tracing No. GAM/BIYA/00/328 made by the Surveyor General, situated in the village of Pahala Biyanwila, in the Divisional Secretary's Division of Biyagama, Gampaha District, and bounded as follows:
