THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Tissa Karalliyaddha Minister of Land and Indigeneous Medicine, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act:

An allotments of land is total extent of about 83.001 Hectares depicted in Advance Tracing No. Ga/Kata/95/260 and December 25th 1995 prepared by the Surveyor-General in village South Kadirana Minor Division of Dunagaha Paththuwa in the Divisional Secretary's Division of Katana in Gampaha District and bounded as follwos.

1. Lot No. 1 – Kaludiyawala Waththa – Extent: 0.138 Hectare

North: Pradesiyasaba Road; East: Ela; South: Lot No. 2; West: Pradesiyasaba Road.
