#### NOTICE UNDER SECTION 104 FOR CANCELLATION OF A GRANT ISSUED UNDER SECTION 19(4) OF THE LAND DEVELOPMENT ORDINANCE

I, A. M. R. J. K. Jayasinghe, Divisional Secretary of the Divisional Secretary's Division of Wanathavilluwa in the North Western Province, have received information that there is no lawful successor, and or is there is a successor he/she has not consented to become such successor to the land more fully described in the schedule hereto, and granted to S.
