THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Tissa Karalliyadda Minister of Lands and Indigenous Medicine, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Land described below, is needed for a public purpose and will be acquired under the provisions of that Act.

Three Lots of Land mentioned below in extent about 0.9631 Hectare and defined as Lots 'A', 'B' and 'C' in the Advance Tracing MR/WLG/2005/309 and dated 22.07.2005 prepared by the Surveyor-General situated in Polwattha Village, Divisional Secretariat Division Weligama, Matara District Southern Province and bounded as follows:

Declaration under Section 5

I, Tissa Karalliyadda Minister of Lands and Indigenous Medicine, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Land described below, is needed for a public purpose and will be acquired under the provisions of that Act.

Three Lots of Land mentioned below in extent about 1.4242 Hectares, defined as Lots 'A', 'B' and 'C' in the Advance Tracing MR/WLG/2005/335 and dated 10.08.2005 prepared by the Surveyor-General situated in Polwattha Village, Weligam Korale West Minor Division, Divisional Secretariat Division Weligama, Matara District and bounded as follows:

1. Lot 'A' – Kambikoruwa – Extent: 1.2328 Hectare
