THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land, which is required for a public purpose :- (For the canteen of unmarried officers of Rattota Police Station)

Description of the land to be acquired :

An allotment of Land in an Extent of 0.1441 Hectare depicted in Preliminary Plan No. P. P. Ma. 1371 of 30. 04. 2003 prepared by Superintendent of Surveys and situated in Rattota Village in Matale Pallesiya Pattuwa Minor Division in Rattota Divisional Secretary's Division in Matale District in Central Province and bounded as follows :
