THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

Divisional Secretary's No.: HP/D/2/LA/69.

I, Disanayake Mudiyanseelage Anura Kumara Disanayake, Minister of Agriculture, Livestock, Lands and Irrigation, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

THE LAND ACQUISITION ACT (CHAPTER 460)**Declaration under Section 5**

I, Disanayake Mudiyanse Anura Kumara Disanayake, Minister of Agriculture, Livestock, Lands and Irrigation hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Three (03) allotments of land in total extent of about 2.788 Hectares depicted in Advance Tracing No. H/BLA/96/399 dated 02.02.1997 prepared by the Surveyor-General situated in the village of Taraperiya in the Divisional Secretary's Division of Beliatta in Hambantota District and bounded as follows:
