THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Disanayake Mudiyanseelage Anura Kumara Disanayake, Minister of Agriculture, Livestock, Lands, and Irrigation do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Eight (8) allotments of land in total extent about 0.0350 Hectare shown as Lot Nos. 1 to 8 in Advance Tracing No. Co/Mo/KOT/03/333/2001/137 and dated 28/11/2003 prepared by the Surveyor-General, situated in the village of Galkissa within the Municipal Council Limits of Dehiwela-Mt. Lavinia in the Divisional Secretary's Division of Ratmalana in the District of Colombo and bounded as follows:

1. Lot No. 1 – 2A, Athula Mawatha, Ratmalana Watta – Extent: 0.0066 Hectare
