#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Disanayake Mudiyanseelage Anura Kumara Disanayake, Minister of Agriculture, Livestock, Lands and Irrigation, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Two (02) allotments of land in total extent of about 0.3541 Hectare, depicted in Advance Tracing No. P/Wen/2004/397, prepared by the Surveyor-General situated in the village of Nainamadama West in the Divisional Secretary's Division of Wennappuwa in Puttalam District and bounded as follows:

**01. Lot 'A' – Dombagahawatte alias Madangahawatte – Extent: 0.0099 Hectare**

North: Andrew Thammel's land of Madangahawatte and Muttuwa Channel; East: Muttuwa Channel and Malith Fernando's land of Madangahawatte; South: Malith Fernando's land of Madangahawatte and Road (Pradeshiya Sabha); West: Road (Pradeshiya Sabha) and Andrew Thammel's land of Madangahawatte.
