REGULATIONS pertaining to payment of travelling expenses to the Mayors, Deputy Mayors and Members, made by Pestheruwe Liyanaralalage Reginold Rosmond Cooray Wijewarnasuriya the Chief Minister and the Minister in charge of the subject of Local Government under the powers vested in me in terms of section 289 of the Municipal Councils ordinance Chapter 252 read with section 2 of the Provincial Act, No. 12 of 1989 (Consequential Provisions) are hereby laid down. These regulations effect from after the Provincial Council Resolution.

REGULATIONS

1. These regulations are known as payment of travelling expenses to the Mayors, Deputy Mayors and Members of the Municipal Councils.

2. Reimbursement of mileage may be made, as follows for the travelling made by the Mayors, Deputy Mayors and Members by their own vehicles for attending to the duties conferred on them by the council.

- * For a Motor Car/Three Wheeler at the rate of Rs. 10/- per mile
- * For a Motor Cycle at the rate of Rs. 4/- per mile
- * When a Public Vehicle is used the actual amount paid for that vehicle shall be reimbursed.

3. The aggregagte travelling expenses paid to a Mayor, a Deputy Mayor or a Member shall be subject to a maximum of 6,000 rupees for a month.

4. When travelling expenses are paid, the work performed shall be the duties conferred by a resolution of the council and shall not be a duty assigned to any official.

5. Further, such duties shall be pertaining to the administration of the council.

6. The travelling claim by a Mayor, a deputy Mayor or a Member shall be mde in accordance with Form General 177 of Government Financial regulations Approval shall be obtained by a council resolution before payment of travelling expenses.

7. The provision for reimbursement of travelling expenses shall only be made in the annual Budget from recurrent revenue.
