FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE NATTANDIYA PRADESHIYA SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the Office of a member in Nattandiya Pradeshiya Sabha has fallen vacant by reason of failure to make and subscribe an oath affirmation in terms of Seventh Schedule of the Constitution of the Democratic Socialist Republic of Sri Lanka ;
