Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Anura Kumara Disanayake, Minister of Agriculture, livestock Lands and Irrigation, hereby declare under sub-section (1) of section 5 of the Land Acquisition Act, that the land described below as needed for a public purpose and will be acquired under the provisions of that Act.

Eighteen (18) allotments of lands in total extent of about 0.2994 Hectare, as Lot No. 01 to 18, depicted in Advance Tracing No. R/ KHW/2002/1132 and 21.11.2002, prepared by the Surveyor General situated in village of Nugawela, (FVP 4) in Minor Division of Pannil Pattuwa in the Divisional Secretary's Division of Kahawatta in Ratnapura District in Sabaragamuwa Province and bounded as follows.

01. Lot No. 1 - Ellegewatta - Extent: about 0.0090 Hectare

North: Balance Portion of this land and Highway; East: Highway and Lot No. 2; South: Lot No. 2, Balance Portion of land owned by W.W. Wickramaratne and Balance Portion of this land; West: Balance Portion of this land.

North: Lot No. 4 and Ela; East: Ela and Lot No. 6; South: Lot No. 6 and Balance Portion of this land; West: Balance Portion of this land and Lot No. 4.

06. Lot No. 6 - Ellegewatta - Extent: about 0.0080 Hectare

North: Lot No. 5 and Ela; East: Ela; South: Ela, Balance Portion of land owned by P.H. Deepani and Balance Portion of this land; West: Balance Portion of this land, Balance Portion of land owned by S.H. Dayani and Lot No. 5.

07. Lot No. 7 - Ellegewatta - Extent: about 0.0005 Hectare

North: Lot No. 6; East: Ela; South: Ela and Balance Portion of this land; West: Balance Portion of this land, Balance Portion of land owned by S.H. Dayanie and Lot No. 6.

08. Lot No. 8 - Ellegewatta - Extent: about 0.1255 Hectare

North: Balance Portion of this land; East: Balance Portion of this land, Balance Portion of land owned by Diyogu Henedige Arther Silva and Lot No. 9; South: Lot No. 9, Balance Portion of land owned by Diyogu Henedige Arther Silva and Balance Portion of this land; West: Balance Portion of this land and Ela.

09. Lot No. 1 - Ellegewatta - Extent: about 0.0150 Hectare

North: Lot No. 8 and Balance Portion of this land; East: Balance Portion of this land, Balance Portion of land owned by Palledallalage Dushmantha Dayaratne and Lot No. 10; South: Lot No. 10, Balance Portion of land owned by Palledallalage Dushmantha Dayaratne and Balance Portion of this land; West: Balance Portion of this land, Balance Portion of land owned by K.A. Siriwardenahamy and Others and Lot No. 8.

North: Balance Portion of this land ; East: Balance Portion of this land, Balance Portion of land owned by Ambalangoda Paragahatotage Sunil Chandrasiri and Lot No. 12; South: Highway; West: Road.

12. **Lot No. 12 - Ellegewatta - Extent: about 0.0003 Hectare**
North: Balance Portion of this land ; East: Lot No. 13 and Highway; South: Highway; West: Lot No. 11.

13. **Lot No. 13 - Ellegewatta - Extent: about 0.0005 Hectare**
North: Balance Portion of this land ; East: Balance Portion of land owned by G. Kusunawathie and Lot No. 14; South: Highway; West: Highway and Lot No. 12.

14. **Lot No. 14 - Ellegewatta - Extent: about 0.0008 Hectare**
North: Balance Portion of this land ; East: Balance Portion of this land; South: Highway; West: Highway and Lot No. 13.

15. **Lot No. 15 - Ellegewatta - Extent: about 0.0019 Hectare**
North: Lot No. 14 and Balance Portion of this land ; East: Balance Portion of this land; South: Highway; West: Highway and Lot No. 14.

16. **Lot No. 16 - Ellegewatta - Extent: about 0.0005 Hectare**
North: Highway; East: Highway; South: Balance Portion of this

land; West: Balance Portion of this land and Highway.

17. **Lot No. 17 - Ellegewatta - Extent: about 0.0004 Hectare**
North: Highway; East: Lot No. 18; South: Lot No. 18 and Balance Portion of this land; West: Balance Portion of this land.

18. **Lot No. 18 - Ellegewatta - Extent: about 0.0050 Hectare**
North: Highway; East: Highway and Balance Portion of this land; South: Balance Portion of this land; West: balance Portion of this land and Lot No. 17.
