THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Disanayake Mudiyanseelage Anura Kumara Disanayake, Minister of Agriculture, Livestock, Lands and Irrigation, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Twelve (12) allotments of land in total extent of about 1.07172 Hectare, depicted in Surveyor-General's Advance Tracing No. Gam/Wath/2003/402 and dated 23.04.2004 as Lot Nos. 1-12 and named and extent as bellow, situated in Matagoda Village, in Ragam Paththuwa Minor Division, in Wattala Divisional Secretary's Division in Gampaha District and bounded as follows:
