#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Dissanayake Mudiyanse Anura Kumara Dissanayake, Minister of Agriculture, Livestock, Lands and Irrigation, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is required for a public purpose and will be acquired under the provisions of that Act.

An allotment of land called Dangaha Idama depicted as Lot A in the Advance Tracing No. PU/A/85/06 made by the Surveyor-General, situated in the village of Kuruketiyawa (B.S.V.P. 3393) in the Kirimetiyapattuwa Minior Division in the Divisional Secretary's Division of Navagattegama, Puttalam District, containing in Extent. 0.1818 Hectare and bounded as follows:

North: Dangaha Idama, claimed by B. Puncha and coconut land;  
East: Dangaha Idama, claimed by B. Puhula, field; South: Dangaha Idama Hena, claimed by B. Tikka; West: Village Council Road from Samurdhigama to Thammenna Vetiya.
