#### FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE BERUWALA URBAN COUNCIL UNDER SECTION 65 A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)
