THE LAND ACQUISITION ACT (CHAPTER 460) AS AMENDED BY THE LAND ACQUISITION (AMENDMENT) ACT, No. 28 OF 1964

Declaration under Section 5

I, Tissa Karaliyadhdha, Minister of Lands and Deshiya Vaidya hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, as amended by the Land Acquisition Act, No. 28 of 1964, that the land described below is needed for a public purpose and will be acquired under the Provisions of that Act ;
