Government Notifications

URBAN DEVELOPMENT AUTHORITY LAW No. 41 OF 1978

Order under Section 3

BY virtue of the powers vested in me under Section 3 of the Urban Development Authority Law, No. 41 of 1978, I Dinesh Chandra Rupasinghe Gunawardene, Minister of Urban Development and Water Supply being of opinion that the area specified in Column I of Schedule II hereto and having the metes and bounds specified in corresponding entry in Column II of Schedule II, except the areas already declared as Urban Development areas and set out in Schedule I hereto are suitable for development and do hereby this order declare such areas to be Urban Development areas for the purpose of the said section.

I do also hereby declare that the already declared areas set out in Schedule I together with the other areas declared as aforesaid, shall be included within the limits of the Greater Dambulla Urban Area set out in Column II under Schedule II hereto.

GREATER DAMBULLA URBAN AREA

Column I

All the land area located within Divisional Secretariat Division of Dambulla, Galewela, Naula (Part) in Matale District of Central Province and Divisional Secretaries Division of Palagala (Part) Kekirawa (Part) Palugaswewa (Part) in Anuradhapura District of North Central Province having the metes and bounds specified in corresponding entry in Column II of this schedule II.

Column II

North :

From the meeting point of Northern and Western boundaries of Horapola G.N. Division No. 644 ; a line drawn Eastwards along the Northern boundary of the said G.N. Division 644 ; until it meets the intersecting point of the Western and Northern boundaries of Unagollewa G.N. Division No. 643 ; thereby a line drawn Northeastward along the Northern boundary of said G.N. Division No. 643 ; until it meets the Northern boundary of Maha Elagammuwa G.N. Division No. 641 ; thereby a line drawn Eastwards along the Northern boundary G.N. Division No. 641 ; until it meets the meeting point of the Southern and Western boundary line of Madagama G.N.D. No. 640 ; thereby a line drawn Northwestward along the Western boundary of the said G.N.D. No. 640 until it meets Western boundary of Ratmallewa G.N.D. NO. 636 ; thereby a line drawn North Eastwards, along the Western, Northern and Eastern boundaries of the said G.N.D. No. 636 ; until it meets the Northern boundary of Kelewa G.N.D. No. 593 ; therein a line drawn South Eastwards along the Northern boundary of the said G.N.D. No. 593 ; until it meets the Northern boundary of Vayaulpatha G.N.D. No. 592 ; therein a line drawn Northeastwards along the said G.N.D. No. 592 ; and along the Northern boundary of Hiriwadunna G.N.D. No. 591 ; until it meets the Western boundary of Habarana G.N.D. No. 589 ; thereby a line drawn Northeastwards along the Western and Northern boundaries of the said G.N.D. No. 589 until it meets the Eastern boundary of the said G.N.D. No. 589.

East :

From the last mentioned point a line drawn South Westward along the Eastern boundaries of the said G.N.D. No. 589 ; and along the Kashyapagama G.N.D. No. 590 ; and along Hiriwadunna G.N.D. No. 591 ; until it meets the Eastern boundary of Matale Districts. Thereby a line drawn South Eastward along the Eastern boundary of Matale District until it meets the centre line of Aban Ganga.

South :

From the last mentioned point a line drawn South Westward along the centre line of the said Aban Ganga until it meets the Southern boundary of Naula D.S. Division ; thereby a line drawn Northwards along the Western boundary of the Naula D. S. Division until it meets Southern boundary at Galewela D.S. Division. Thereby a line drawn North Westwards along the Southern boundary of the said D.S. Division until it meets the Western boundary at Matale District.

West :

From the last mentioned point a line drawn North Westwards along the Western boundary of Matale District until it meets the centre line of Hawan Ella Oya, thereby a line drawn Northwards along the centre line of said Oya until it meets the Southern boundary of Balalu Wewa ; thereby a line drawn North Eastward along the Southern and Eastern boundary of Balalu Wewa and Eastern boundary of Kala Wewa until it meets the starting point.
