### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Tissa Karaliyadda, Minister of Lands and Indigenous Medicine do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Nine (09) allotments of land in extent 21.6665 Hectares shown as Lot Nos. 4, 5A, 5C, 5J, 6, 7C, 11, 14 and 16 in Advance Tracing No. ෧෧/ ජාඇල/93/020 and dated 29.06.1994, prepared by the Surveyor-General, situated in the Village of Ragama within the Divisional Secretary's Division of Ja-Ela in the District of Gampaha and bounded as follows:
