THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Tissa Karalliyadda, Minister of Lands and Indigenous Medicine, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

An allotment of land called Punchiliadda *alias* Podisanige Kotuwa and Aththanawalawatta, together forming northern part of land called Athuwala as Lot A depicted in Plan No. GA/BALP/04/78, dated 26th April, 2004, made by the Surveyor-General, conforming in extent 0.487 Hectare, situated in Kosgoda village in Balapitiya Divisional Secretary's Division in the Galle District in the Southern Province and bounded as follows:

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Tissa Karalliyadda, Minister of Lands and Indigenous Medicine here by declare under Sub section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Fifteen (15) allotments of land called Ussaththwa in total extent about 17.457 Hectares, depicted in the Advance Tracing No. Ma/NUL/2004/531 of 15th February, 2005, prepared by the Surveyor-General Matala situated in the village of Ussaththawa (F.V.P. 255) in the Minor Division in the Divisional Secretary's Division of Naula, Wagapanaha Udasiya Pattuwa in the Matala District and bounded as follows:

01. Lot A – Wemedilla – Extent about: 2.550 Hectares

North: Land claimed by S. G. J. Benjamin; East: Lot F and Wemedilla claimed by S. G. P. Selastian and U. G. Samarkoon; South: Foot path from Main Road towards houses, Lot No. H, G and Welamitiyawa Oya; West: Welamitiyawa Oya.

North: Lot A and foot path from Main Road to houses; East: Foot path from Main Road to houses and road to Pannampitiya from Main Road; South: Road to Pannampitiya from Main Road and Lot H; West: Lots H and A.

08. Lot H – Wemedilla – Extent about: 0.996 Hectare

North: Lot A and G; East: Lot G and road from Main Road to Pannampitiya; South: Welamitiya Oya and road from main road to Pannampitiya; West: Welamitiya Oya.

09. Lot J – Wemedilla – Extent about: 0.401 Hectare

North: Road from Main Road to Pannampitiya; East: Lot E and K; South: Lot K and Ela; West: Road from Main Road to Pannampitiya.

10. Lot K – Wemedilla – Extent about: 0.401 Hectare

North: Lot E and road from Main Road to Pannampitiya; East: Road from Main Road to Pannampitiya and Lot L; South: Lot L and Ela; West: Lots J and E.

11. Lot L – Wemedilla – Extent about: 1.149 Hectares

North: Lot K and road from Main Road to Pannampitiya; East: Wemedilla, claimed by S. P. W. Wijerathne; South: Wemedilla, claimed by S. P. W. Wijerathne and Ela; West: Lot K.

12. Lot M – Wemedilla – Extent about: 0.986 Hectare

North: Wemedilla, claimed by S. P. W. Wijerathne; East: Lot K, road from Main Road to Pannampitiya and Lot N; South: Lot N; West: Wemedilla, claimed by S. P. W. Wijerathne.

13. Lot N – Wemedilla – Extent about: 1.429 Hectares

North: Lot M; East: Road from Main Road to Pannampitiya; South: Road from Main Road to Pannampitiya and Ela; West: Ela, Wemedilla, claimed by S. P. W. Wijerathne and Lot M.

14. Lot P – Rideegamayaya – Extent about: 1.310 Hectares

North: Rideegamayaya, claimed by C. G. Simiyon Appu and D. G. Selinahami; East: Rideegamayaya, claimed by D. G. Selinahami and Crown Land; South: Crown Land and Rideegamayaya, claimed by T. M. E. G. W. Dammika Bandara; West: Rideegamayaya, claimed by T. M. E. G. W. Dammika and C. G. Simiyon Appu.

15. Lot Q – Niyanakolamadayaya – Extent about: 1.116 Hectares

North: Niyanakolamadayaya, claimed by Y. N. Piyasiri, R. M. K. G. Dingiramma and G. M. Tikiribanda; East: Niyanakolamadayaya, claimed by G. M. Tikiribanda; South: Niyanakolamadayaya, claimed by P. G. Ranathunga, Y. M. Weerasinghe and Ela; West: Ela, Weragalayaya, claimed by A. P. Tikiribanda and Niyanakolamadayaya, claimed by Y. N. Piyasiri.
