THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Tissa Karalliyadda, Minister of Lands and Indigenous Medicine, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Three (03) allotments of land called at Lourmantwatta in total extent of about 1.515 Hectares, as Lots 1 to 3, depicted in Advance Tracing No. KA/DDN/04/62 and 18.03.2004, prepared by the Surveyor General situated in village of Gamagoda in Minor division of Totamuna North in the Divisional Secretary's Division of Dodangoda in Kalutara District in Western Province and bounded as follows:

1. Lot No. 1 – Lourmantwatta – Extent: 0.025 Hectare

North: Tittaweli Godella land claimed by L. R. Peiris and Road; East: Road; South: Tittaweli Kumbura claimed by M. D. M. Munasinghe; West: Tittaweli Kumbura claimed by M. D. M. Munasinghe and Tittaweli Godella Idama claimed by L. R. Peiris.
