THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Thissa Karalliyadda, Minister of Lands and Deshiya Vaidya hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, as amended by the Land Acquisition Act, No. 28 of 1964, that the land described below is needed for public purpose and will be acquired under the Provisions of that Act.
