I, Tissa Karalliyadda, Minister of Lands and Indigenous Medicine hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public and will be acquired under the Provisions of that Act ;

Six (6) allotments of land in total extent of about 3.415 Hectares (8A.,01R.,30P.) depicted in Advance Tracing No. GA/GFG/05/403 of prepared by the Surveyor General situated in the Village of Dadalla in the Divisional Secretary's Division of Four Gravets, Galle in Galle District, Names and extent of the said allotments of land are as follows :
