THE JUDICATURE ACT, No. 2 OF 1978

Order under Section 3

BY virtue of the powers vested in me by Section 3 of the Judicature Act, No. 2 of 1978, I, Welathanthrige Don John Seneviratne, Minister of Justice and Judicial Reforms, in consultation with the Chief Justice and the President of the Court of Appeal, do by this Order, with effect from 01st October, 2005, amend the Schedule to the Order made under Section 3 of the aforesaid Act, and published in *Gazette Extraordinary* No. 43/3 of July 02, 1979 as last amended by Order published in *Gazette Extraordinary* No. 1409/20 of 09th September, 2005 with reference to the item “Badulla” appearing in Column I thereof under the heading “Zone”, as follows :-
