THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksha, the Minister of Agricultural Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksha, the Minister of Agricultural Development hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Two (02) allotments of land in total extent of about 8.974 Hectares, depicted in Advance Tracing No. Maha/DLT/2003/398, prepared by the Surveyor-General situated in the village of Uda Delthota in the Minor Division in the Divisional Secretary’s Division of Delthota, Gan Dahaya South 11 in Kandy District and bounded as follows:
