### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Thirteen (13) allotments of lands in total extent about 0.1201 Hectare, depicted in Amended Advance Tracing No. CO/MO/RAT/2004/253 of 23rd August, 2004, prepared by the Surveyor-General, situated in the village of Ratmalana North in the Divisional Secretary's Division of Ratmalana in Colombo District and bounded as follows:
