#### Declaration under Section 5

I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development, hereby declare, under sub section (1) of section 5 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act :-

An allotment of land called Matihakkawatte in extent of about 17.1735 Ha. depicted as a Lot No. 1 in Advanced Tracing No. GAM/MIRI/2004/11 of 03.12.2004 prepared by the Surveyor General, situated in the village of Debahera in Minor Division of Udugahapaththuwa, Mirigama Divisional Secretary's Division in Gampaha District and the boundaries are as follows:

#### Lot No. 01 - Land Extent - 17.1735 Ha.
