#### Land Reform Law No. 1 OF 1972

#### ORDER UNDER SECTION 27 (A) (4)

BY virtue of the powers vested in me by Section 27 (A) 4 of the Land Reform Law, No. 1 of 1972 as amended by Act, No. 39 of 1975, Act, No. 14 of 1981, Act, No. 39 of 1981 and Act, No. 14 of 1986 and Act, No. 18 of 1986, I, Chamal Rajapakse, Minister of Agriculture Development in pursuance of the Provisions of the said Land Reform Law as amended and the terms and conditions of the order under Section 27 A (4) of the Land Reform Law, No. 1 of 1972 vesting a portion of land containing in extent 622.63 Hectares from Bohil Estate, in Kandy District in the Janatha Estate Development Board established under the State Agriculture Corporation Act, No. 11 of 1972 and published in the *Gazette Extraordinary* Part I : Section (I) – General No. 195/6 of 31.05.1982 of the Democratic Socialist Republic of Sri Lanka, do hereby revoke the order pertaining to the extents of land described in Schedule (1), (2) and (3) hereto.
