THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Four (4) allotments of land in total extent of about 7.905 Hectares, depicted in Advance Tracing No. F.V.P. 176, prepared by the Surveyor-General, situated in the Village of Wattepanguwa in the Divisional Secretary's Division of Hali-Ela in Badulla District and bounded as follows:

**01. Lot No. 175 – Uduwara Watta Estate, Lower Division
