THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Description of the land to be acquired:

Declaration under Section 5

I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.
