3. Whether the non payment of salary for the period of interdiction from 27/09/1995 to 20/01/1999 of Mr. G. A. D. T. Jayaratne who is presently employed at Sri Lanka Telecom Limited is justified and to what relief he is entitled and
4. Whether the non granting of the two salary increments which were deferred for the period of interdiction of Mr. G. A. D. T. Jayaratne is justified and to what relief he is entitled.
