#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land depicted as Lots A, B, C and D in Advance Tracing No. KA/BRW/05/277 and dated 25.07.2005 made by the Surveyor-General situated in the village of Pinidiyamulla in the Divisional Secretariat Division of Beruwala, in the District of Kalutara, Western Province and containing in extent of about 4.587 Hectares and bounded as follows :

##### Declaration under Section 5
