#### AMENDMENT

#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### Declaration under Section 5

The word “**servitude**” was erroneously published instead of the word “**Land**” in the notification in the Extraordinary Gazette of *Democratic Socialist Republic of Sri Lanka* on 29th August 2005 and bearing No. 1408/6. It is hereby declared that the exact word should be “**Land**” and not **servitude**.

#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### Declaration under Section 5

I, Chamal Rajapaksa, Minister of Agriculture Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

An allotment of land called “Sittampalamwatta” in total extent of 21.735 Hectares, depicted as Lot No. ‘A’ of Advance Tracing No. 92/307 dated 30.07.1992, prepared by the Surveyor General, situated in the village called Pottukulam (F. V. P. 240 A) of Kumara Pallama Pattuwa Minor Division of the Divisional Secretary’s Division of Pallama in Puttalam District and bounded as follows:

North: Lot Nos. 456, 462, 461, 460, 459, 450 and 451 of F. V. P. 240A, and Sittampalamwatta (owned by Janatha Estate Development

#### Declaration under Section 5

I, Tissa Karalliyadda, Minister of Lands and Indigenous Medicine, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Two blocks of land called Danapala, Dahapela and Odekumbura containing nearly 0.0400 Hectare in extent depicted as lot Nos. 1 and

2 in the Advance Tracing No. H/TSS/2003/385 dated 30.03.2004, prepared by the Hambantota District Superintendent of Surveys, situated in the village of Lukasgoda in the Division of Sulu in the Magampattuwa in the Divisional Secretary's Division of Tissamaharamaya in Hambantota District and bounded as follows:
