I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose :-

8053, 8054, 8055, 8056, 8057, 8058, 8059, 8060, 8061, 8062, 8063, (11) allotments of land in total extent about 0.2570 Hectare, called Kinniya Thottam, depicted in final Topo Plan 6, Sheet No. 309 of 20. 12. 2005 prepared by the Surveyor General, Trincomalee, situated in the village Sinnakinniya of Rahumaniya, Nagar G.
