THE URBAN DEVELOPMENT AUTHORITY LAW, No. 41 OF 1978

Order under Section 3

BY virtue of the powers vested in me under Section 3 of the Urban Development Authority Law, No. 41 of 1978, I, Dinesh Chandra Rupasinghe Gunawardene, Minister of Urban Development and Water Supply, being of the opinion that the area specified in Column I of the Schedule appended hereto, having the metes and bounds specified in the corresponding entry in Column II of that Schedule is suitable for development, do by this Order declare such area to be an Urban Development Area.

SCHEDULE

Column I

All the land area comprising following Grama Niladhari Division, No. 114, Deraniyagala North, No. 114C, Lassegama, No. 114E, Deraniyagala South, No. 114D, Wattegedara in Deraniyagala Divisional Secretariat area in Kegalle District in the Sabaragamuwa Province and having the metes and bounds specified in corresponding entry in Column II.

Column II

North : A line drawn towards East from a Starting point where the Western boundary of Wattegedara G.N. Division No. 114D, meets the center of the culvert No. 1/10 on Dehiowita-Deraniyagala main road along the northern boundary of Wattegedara G.N. Division No. 114D until it meets a point where the Western and Northern boundaries of Udabage G.N. Division No. 111 meets.

East : From the last mentioned point a line drawn towards South, along the Western boundary of Udabage G.N. division No. 111 until it meets the Southern boundary of Lassegama G.N. Division No. 114C.

South : From the last mentioned point a line drawn towards West along the Southern Boundary of Lassegama G.N. Division No. 114C, crossing Deraniyagala-Maliboda Road until it meets the Northern boundary of Miyanawita G.N. Division No. 114G, Thence along the said boundary until it meets the Eastern boundary of Rasnakkanda G.N. Division No. 114B.

West : From the last mentioned point a line drawn towards North along the Eastern and Northern boundaries of Rasnakkanda G.N. Division No. 114B until it meets the Western Boundary of Rasnakkanda G.N. division No. 114B, Thence towards North-West along the Western and Northern Boundries of Deraniyagala South G.N. Division No. 114E until it meets the Western Boundary of Wattegedara G.N. Division No. 114D. Thence along the Western Boundary of the said G.N. Division No. 114D until it meets the starting point.
