REGISTRATION OF ELECTORS ACT, No. 44 OF 1980

Notice under Section 13(2)

REVISION OF REGISTERS OF ELECTORS - 2005

NOTICE is hereby given today, 03rd January, 2006 under Section 13(2) of the Registration of Electors Act, No. 44 of 1980, that -

- (1) List “A” containing names of person in the register of electors who are dead or have become disqualified ; and
- (2) List “B” containing the names of persons who are not being already in the registers of electors or otherwise disqualified to appear to the Registering Office to be qualified to have their names entered in the register,

have been completed in respect of the above Electoral District and that register in operation and such lists or portions thereof are open for inspection during office hours as follows :

<i>Places of Exhibition</i>	<i>Register and Lists or Portions thereof for Exhibition</i>
(1) Each District Election Office	Complete copy of the register in force for the relevant Electoral District and of the related Lists “A” and “B”
(2) Each Divisional Secretariat	Portion of the copy of register in force containing all Polling Districts lying within the Divisional Secretary’s area and of the related List “A” and “B”
(3) Office of each Local Government Authority	Portion of the copy of Register in force containing all Polling Districts lying within the office of the Local Government Authority area and of the related Lists “A” and “B”
(4) Each Grama Niladhari’s Office	Portion of the copy of register in force containing all Polling Districts lying within the Grama Niladhari’s Division and of the related List “A” and “B” ;

(5) Each Post Office

Portion of the copy of the register in force containing the Polling Districts within which the Post Office is situated and of the related Lists "A" and "B" ;

02. Where a person who is qualified in accordance with the said Registration of Electors Act to have his name entered in the register of electors for the above Electoral District and whose name has been omitted from such register and from List "B" or whose name has been included in the List "A" and who claims to have his name inserted or retained as the case may be, in the register, that person or any other person on his behalf may make a claim in writing to the Registering Officer of the relevant District Elections Office, substantially in Form "A" or "B" as the case may be specified in the Schedule to the said Act. Every such application should reach the Registering Officer of the relevant District Elections Office, within four weeks from the date of publication of this notice in the *Gazette* of the Democratic Socialist Republic of Sri Lanka.

03. Any person whose name appears in the Register of Electors or the List "B" for the above Electoral District may object to the inclusion in such register of his own name or the name of any other person appearing in such register or List "B" or to the insertion or retention in the register of the name of any claimant, in duplicate to the Registering Officer of the relevant District Elections Office, substantially in Form : "C" or "D" as the case may be specified in the Schedule to the said Act. Every objection to the inclusion of any name in the register or List "B" should reach the Registering Officer of the relevant District Elections Office, within four weeks from the date of publication of this notice in the *Gazette* of the Democratic Socialist Republic of Sri Lanka. Every objection in the insertion or retention in the register of the name of claimant should reach the Registering Officer within fourteen days from the date on which a notice containing the names of claimant is exhibited at Each District Elections Office.

Such notice will be exhibited at each District Elections Office on 17th January, 2006 and 31st January, 2006.

04. Forms for the purpose of making any claim or objection may be obtained from each District Elections Office, each Divisional Secretariat, Office of each Local Government Authority, each Grama Niladhari's Office and each Post Office.
