- (a) by the deletion of the words : “supervision, registration and assistance to Social Welfare Voluntary agencies” appearing in Column II under the Heading “Minister of Plan Implementation”
- (b) by the inclusion of the following words at the end of Column II under the Heading “Minister of Social Services and Social Welfare” :

“Administration of the Voluntary Social Service Organizations (Registration and supervision) Act, No. 31 of 1980”.

“Administration of the Protection of the Rights of Elders Act, No. 9 of 2000”.

- (c) by the deletion of the following words appearing in Column II under the Heading “Minister of Social Services and Social Welfare” and by the inclusion of the same at the end of Column II under the Heading “Minister of Plan Implementation”

“Coordination of the implementation of programmes of Government and Non-Government Agencies for the achievement of National Objectives”.

- (d) by the deletion of the following words appearing in Column II under the Heading “Minister of Foreign Affairs” and by the inclusion of the same at the end of Column II under the Heading “Minister of Labour Relations and Foreign Employment”

“Wages, terms and conditions of foreign employment”

“Regulation of fee levying of employment agencies”.

- (e) by the inclusion of the following words at the end of Column II under the Heading “Minister of Labour Relations and Foreign Employment”

“Unemployment Benefit Insurance Scheme”

“Administration of Sri Lanka Bureau of Foreign Employment Act, No. 20 of 1985”.

- (f) by the inclusion of the words : “Nuwara-Eliya General Hospital” at the end of Column I under the Heading “Minister of Healthcare and Nutrition”

- (g) by the inclusion of the words : “Lanka Cement Ltd.” at the end of Column I under the Heading “Minister of Industrial Development”

- (h) by the substitution, in the Sinhala version of the said Notification, of the words : “විදේශගත රාජ්‍ය දූත මණ්ඩල” for the words : “විදේශගත රාජ්‍ය දූත සේවා” appearing in Column I under the Heading “Minister of Foreign Affairs”.
