**AIR NAVIGATION ACT (CAP.365 L.E.C.) AS AMENDED BY THE AIR NAVIGATION (SPECIAL PROVISIONS)

Order under Section 23 (3) (a)

BY virtue of the powers vested in me by Section 23 (3) (a) of the Air Navigation Act, (Cap. 365 L.E.C.), as amended by the Air Navigation (Special Provisions) Act No. 2 of 1982 and by the Air Navigation (Special Provisions) Act No. 11 of 1983, read with Article 44 (2) of the Constitution, I, Mangala Samaraweera, Minister of Ports and Aviation, do by this order specify that the Agent shall retain as a fee for the services provided by the Agent in the discharge of his functions for the calender years 2004 and 2005 forty percent of the fees, taxes or charges collected or recovered by the Agent on behalf of the Government.

**AIR NAVIGATION ACT (CAP.365 L.E.C.) AS AMENDED BY THE AIR NAVIGATION (SPECIAL PROVISIONS)
ACT No. 2 OF 1982 AND AIR NAVIGATION (SPECIAL PROVISIONS) ACT No. 11 OF 1983**

Order under Section 23 (3) (b)

BY virtue of the powers vested in me by Section 23 (3) (b) of the Air Navigation Act, (Cap. 365 L.E.C.), as amended by the Air Navigation (Special Provisions) Act No. 2 of 1982 and by the Air Navigation (Special Provisions) Act No. 11 of 1983, read with Article 44 (2) of the Constitution, I, Mangala Samaraweera, Minister of Ports and Aviation, with concurrence of the Minister In-Charge of the subject of Finance do hereby determine, that the Agent shall for the purpose of capital expenditure for development, on behalf of the government, of Aerodromes and Airports, retain, thirteen percent of the fees, taxes or charges

collected during the calendar years 2004 and 2005, by such Agent on behalf of the Government, provided that the sum to be retained shall not exceed the fees or charges recovered by such Agent as aforesaid, in connection with the landing, using or parking of aircraft in the years 2004 and 2005.
