THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Two (02) allotments of land known by the undermentioned names and in total extent of about 0.1790 Hectare, depicted in Advance Tracing No. KA/HRN/03/245, prepared by the Surveyor-General, situated in the village of Horana East in the Divisional Secretary's Division of Horana in Kalutara District and bounded as follows:

01. Lot No. 1 – Paddy field at Eli Ahumandiya – Extent: About 0.1703 Hectare

North: Paddy field at Eli Ahumandiya, claimed by D. S. R. Pathirage, paddy field at Eli Ahumandiya, claimed by S. Athukorala and others, Kekunagahahena, claimed by the State and canal; East: Eli Ahumandiya paddy field claimed by S.
