### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Notice under Section 7

Reference No.: Ga/GFG/LA/3/2/2005/04.

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose :-

Description of the land to be acquired :

The land in total extent of about 2.894 Hectares depicted in Plan No. P.P.G. 3466 prepared by the Surveyor-General, situated in the village of Dadalla in the Thalpepattu South in the Divisional Secretary's Division of Four Gravets Galle in the District of Galle, Southern Province. The name extent and boundaries of the aforesaid land are as follows:

**1. Lot No. 1 – Walauwatta *alias* Kiripattiyawatta *alias* Beligahawatta – Extent: 2.894 Hectares**

North: Main Road and Lot No. 2 of Plan No. 3466 and Canal; East: Lot No. 2 of Plan No. 3466, Canal, Al-mubarak College, Kiripattiyawatta (the claimant is not known) and Pahaliyapalawatta claimed by N. S. M. Mendis and others; South: Kiripattiyawatta (the

claimant is not known) Pahaliyapalawatta claimed by N. S. M. Mendis and others, Kovila Road, Millawatta claimed by Shelton Jayasinghe and others, Punchibandaragewatta claimed by Kalinga Lionel and others and Kiripattiyawatta (claimant is not known); West: Kovila road, Millawatta claimed by Shelton Jayasinghe and others Punchibandaragewatta claimed by Kalinga Lionel and others, Kiripattiyawatta (the claimant is not known) and Main Road.

All persons interested in the aforesaid land are hereby required to appear personally, or by agents duly authorized in writing, before me at Divisional Secretariat, Galle-Kadawath Sathara on 21st day of April, 2006 at 10.00 a.m. and are hereby requested to notify to me in writing (in duplicate) on or before the 5th day of May, 2006, the nature of their interests in the land, the particulars of their claims for compensation for the acquisition of the said land, the amount of compensation and the details of the computation of such amount.
