I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose :-

Description of the land to be acquired :

Seven allotments of land in extent of 2.748 Hectares, shown as Lot Nos. 01, 02, 03, 04, 05, 06 and 07 in the Preliminary Plan No. Gam. 3528, prepared by the Superintendent of Surveys, In-charge of Gampaha Division on behalf of the Surveyor-General, situated in Eththukala village in Dasiyapattu in the Divisional Secretary's Division of Negombo in Gampaha District in the Western Province and bounded as follows:
