SOUTHERN PROVINCE PROVINCIAL COUNCIL

Notice under Section 185 of the Pradeshiya Sabha Act, No. 15 of 1987, read with Section 2 of the Provincial Council (Consequential Provisions) Act, No. 12 of 1989 and Section 3 of the Southern Provincial Council's Local Authorities Administrative Supervision Powers Statute, No. 4 of 1990

I, Shan Vijayalal de Silva, Subject Minister of Law and Order, Local Government, Education, Transport, Cultural, Environment, Information, Water Supply, Estate Infrastructure and Tourism, of the Southern Provincial Council do in Pursuance of the Provisions of Section 185 (2) of the Pradeshiya Sabha Act, No. 15 of 1987 read with Section 2 of the Provincial Council's (Consequential Provisions) Act, No. 12 of 1989 and Section 2 (2) of the Southern Provincial Council's Local Authorities Administrative Supervision Powers Statute, No. 4 of 1990, appoint Mr. Ajitha Piyaransi Pandita Gunawardena, retired Judicial Officer for the purpose of inquiry into the matters related to Section 185 (1) of the Pradeshiya Sabha Act and Section 2 (1) of the Southern Provincial Council's Local Authorities Administrative Supervision Powers Statute No. 4 of 1990, and to report the conduct of Mr. Miyanawatura Pahala Gamage Piyasena when functioning as Chairman of the Kotapola Pradeshiya Sabha of Matara District.

02. Furthermore by virtue of Powers vested in me under Section 185 (3) (a) (i) Pradeshiya Sabha Act, No. 15 of 1987, read with Section 2 of the Provincial Councils (Consequential Provisions) Act, No. 12 of 1989 and Section 3 of the Southern Provincial Council's Local Authorities Administrative Power Statute No. 4 of 1990, I, Shan Vijayalal de Silva Subject Minister of Law and Order, Local Government, Education, Transport, Cultural, Environment, Information, Water Supply, Estate Infrastructure and Tourism, Southern Provincial Council, do hereby suspend with immediate effect, the functions and duties of Mr. Miyanawatura Pahala Gamage Piyasena as Chairman of the Kotapola Pradeshiya Sabha of Matara District.

03. Furthermore as I have suspended the Chairman of the Kotapolas Pradeshiya Sabha, I direct Mr. Ambewela Dhammika, the Vice Chairman of the Kotapola Pradeshiya Sabha, to exercise the powers and perform the duties of the Chairman of the Kotapola Pradeshiya Sabha with immediate effect according to the Section 185 (3) (a) (i) of the Pradeshiya Sabha Act, No. 15 of 1987, read with the Section 2 of the Provincial Council's (Consequential Provisions) Act, No. 12 of 1989, and Section 3 of the Southern Provincial Council's Local Authorities Administrative Suspension Powers Statute No. 04 of 1990.
